

To All Excelsior Owners:

The Board of Directors is proposing a Special Assessment broken down into three segments. The appropriate back up for each segment is attached.

Segment 1 deals with our cash shortage. As you will recall we had announced previously there would be an operating deficit for 2023 of an estimated amount of \$64,000 pending the final review by the accountant. Last years' special assessment included \$395 a unit to repay reserves what we borrowed to pay the insurance. The accountant has reclassified that amount to operating which effectively wiped out the deficit. This was a good thing from a financial statement standpoint with banks and prospective new owners. However, this left us with not enough cash to repay reserves. Since the review took 6 months to complete and I had already transferred money to reserves (Reserves are fully funded for 2023), that left us short on operating money for 2024 and money to start funding the 2024 reserves. Schedule 1 is a breakdown of our projected expenses and cash flow to 10/1/2024. Basically, it is the 2023 deficit and the current deficit to date.

Segment 2 consists of the items that were overbudgeted or not budgeted. Tree trimming will exceed the budgeted amount even after obtaining a quote and hiring a new tree trimmer. We could put on hold mangrove trimming and some other items, but this really needs to be done. City Wide was not budgeted since they were hired after the 2024 Budget was approved. Their services have been eliminated with the hiring of extra maintenance staff. The SIRS study is the new Reserve study required by law and again was not known before the 2024 budget was set. Irrigation Maintenance is the estimated amount over budget to replace the older portions of our system not in working order.

Segment 3 are new items for consideration. As you all know, the FOB system has cost many hours on Dan's part and IT technicians. The bottom line is the system needs to be upgraded at a cost of over \$20,000. The REC will be contributing a large portion of this cost as the renter FOBs require more work. Several quotes were obtained, and CIA is the committee recommendation. The situation with the sod was caused by the drought of the summer of 2023. We could postpone this until 2024 but it needs to be done. The better time to do this is now with the summer rains. Some have come back but many areas are now just weeds. The upgrade to the irrigation system will ensure that all areas of new sod will be reached by irrigation. The committee asked several other companies to quote but all declined. The estimates for each item are attached.

The Board feels this is a necessary assessment to bring our Reserves and Cash flow in line, address our overbudget items and keep the property up to the standards we all expect.
